Employment Law for Managers and Business Leaders (minimum 1 day course)

Employment law can be complex, with the legal landscape constantly evolving and changing.

Equality, diversity, and inclusion (half day course)

The Equality Act 2010 provides legal protection for nine protected characteristics: age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation.

Our course looks at the 4 main types of discrimination; direct and indirect, harassment and victimisation and will ensure that you and your management team have the necessary skills and understanding to provide a fully inclusive working environment that removes the risk of disruptive and costly discrimination claims.

Undertaking this training will also help protect your business in respect of any harassment claims. The defence for harassment is that the employer "took" all reasonable steps to prevent the harassment from occurring. This means that an employer has a positive duty to ensure staff are furnished with the relevant information around what constitutes harassment.
